Summary of Email discussion in lieu of a Committee Meeting April 2020

Matters arising from 31/01/2020 meeting:-

- 3. There is no point issuing membership cards at the moment. If the BBQ on 20 July goes ahead, it would be an opportunity to give them out then. David has suggested it may be useful to email members to ask if they wish to renew their membership and we would then be ready to either issue them when we know when we will start walking again, and/ or issue virtual cards in the interim.
